As a result of the lockdown re-introduced on 4th January, there has still been virtually no GA activity since the last Newsletter. But, as many will, of course, know, the UK Government has introduced a "Road Map out of Lockdown" so hopefully things may improve slightly if all goes according to plan....

MARCH WEATHER

This month, remaining in the lockdown, and with Leisure Flying prevented under law, again the weather has again been somewhat irrelevant, as we have virtually all been unable to fly.

BUT – we have a Roadmap now to hopefully come out and return slowly towards normality over a few months....!

BIGGIN HILL AIRPORT NEW DISCOUNT SCHEME

The airport has just announced a very generous new discount scheme for Biggin Hill based Privately Owned aircraft – known as the "Home Based Aircraft Discount Scheme". This is introduced in tandem with a promise to maintain the current landing fee rates after April 1st for the next year, the point at which there would usually have been an increase in charges.

Owners of Biggin Hill Based private aircraft will need to apply for this discount and mark the PPR form with the scheme name above.

UK ROADMAP OUT OF LOCKDOWN

As mentioned above, the UK Government has published it's "Roadmap out of Lockdown" with guidelines as to how the changes to the law will affect General Aviation. Some people are claiming that as they are called guidelines, they can pretty much ignore them.... Not so!

The published guidelines are simply guidelines to the actual law to make it less daunting to have to try to understand the actual written law....

So, what are the Roadmap Steps:

STEP 1

This Step commences on 29th March, and will allow licenced pilots who are in recency to fly solo.

Provided they can satisfy the 90 day rule (3 take offs and landings within the last 90 days), then they can carry a passenger or passengers who are within the pilot's own household or bubble.

Flying training for recreation or leisure purposes is not permitted. ie. No PPL training or dual flying with an instructor. This means that someone who is out of current flying practice and therefore requires a check out with an instructor cannot fly as this is not permitted.

STEP 2

This Step, that will commence no earlier than 12th April, allows for flight training or flights with an instructor to recommence. This is the first point at which a dual check ride is acceptable. It is therefore the point at which clubs and schools can recommence operations...

STEP 3

This Step, that will commence no earlier than 17th May, is principally the point at which some larger sporting events and similar may be permitted subject to suitable social distancing etc.

Meeting others outdoors will be permitted but not with groups of 30 or more which will remain illegal. Currently the suggestion is that indoor meetings socially of up to 6 persons or 1 other household may be permitted (but this could be increased according to the data at that time.

STEP 4

This Step, that will commence no earlier than 21st June, is the point at which the Government hope to remove all legal limits on social contact, and reopen any remaining closed settings.

(Nothing in this Roadmap affects training for the provable purpose of obtaining a professional pilots licence, which is allowed to operate throughout the period.

The CAA, having been put under much pressure by many of us, have now issued a Safety Notice SN-2021/009 dated 22nd March 2021, which actually clarifies the fact that dual checks are not permitted under Step 1

The DfT have actually advised the CAA that it is their intention to prosecute persons breaking the law, so please be careful.....

RESTARTING FLYING

Please re-familiarize yourselves with the noise sensitive areas adjacent to the airport that should be avoided, and of course follow all the published airport's noise abatement procedures. Being a good neighbour will obviously help to avoid anti-airport issues for us all.

Check NOTAM's and the A.I.P. before getting airborne again....

Finally, as we said last month, please check that your Pilots Licence and Medical are still current and valid.

Is your SEP or other expiring ratings still shown as still valid on your licence?

And remember, you cannot carry any passengers unless you have provably completed 3 take offs and landings within the preceding 90 calendar days!

APRIL BIGGIN HILL POSTED FUEL PRICES

The "posted" Biggin Hill Airport fuel prices, excluding VAT, for the calendar month of April 2021 are:

£1:57.0 per litre for 100LL Avgas if supplied from the Fuel Bowser (if uplifted <u>using account card</u> Only from the Self-Refuel pumps = minus 4p per litre)

<u>SPECIAL NOTES:</u> Users should be aware that <u>credit and debit cards</u> <u>cannot currently be used at the self-refuel pumps.</u> The situation is likely to remain this way for some time, so if you use self-refuelling, please make sure you have your airport H-TEC fuel account card with you when you go there.

<u>WARNING:</u> For those that, in the past, may have used credit/debit cards for your fuel payments, you should be aware that a recent system audit has shown that a number of payments did not go through the recipient's bank accounts. As a result, these missed payments will be collected as a part of this backlog in due course.

MONTHLY NEWS FROM THE CEO's OFFICE

The focus for the Airport throughout March has centred on engagement with the government through the Global Travel Task Force and preparations for the lifting of restrictions for GA flying. Additionally, the Airport has created its own internal process for lifting restrictions which mirrors the four-step approached announced by the government. With a clear roadmap and the continued success of the vaccine rollout, the Airport believes we are seeing the first real early signs of recovery but we wait with baited breath regarding the recommendations due to be made by the Global Travel Task Force on 12th April.

The Airport, like all businesses in our sector, continues to navigate through the economic challenges presented by the 3rd National lockdown. Trading throughout March has been severely limited and this has made for a very lean last quarter of this financial year. Traffic levels throughout January, February and now March remain more than 50% down on what we would have expected throughout this period.

In my last newsletter update I expressed frustration at the fact that many small airports across the UK had been excluded from the government's Airport Ground Operations Support Scheme and I find myself equally frustrated that despite extensive lobbying, the government will not be

extending the eligibility terms to include smaller airports. The failure to acknowledge the delicate balance of the wider aviation Eco system will undoubtedly put many small airports at risk.

Those of you that have been at the Airport recently will have noticed the continued progress with the Bombardier hangar, the hoarding being put up around the Hotel site and the new ILS localiser in place. This continued investment in airport infrastructure is critical to ensure the Airport is well placed to take advantage of the recovery when it comes. Hopefully, we can pick up the pace shortly regarding additional apron works in front of hangar 446 and the resurfacing works planned for Foxtrot taxiway. Unfortunately, whilst we continue to make progress regarding the implementation of the 03 RNAV approach, it's in operational date will be towards the end of this summer.

As I write this update, we are literally days away from the start of the lifting of restrictions on some GA flying activity. Whilst this is great news for us all, this is a timely opportunity for me to stress the importance of addressing any potential skills fade that might have occurred during the lockdown. I feel, in the interest of flight safety, it is an imperative that we all take a measured approach to getting back in the air. The CAA have recently issued a Safety Notice SN-2021/008 covering aspects for the safe return to normal operations. Additionally, I would stress the need for everyone to take the necessary steps they feel are appropriate for a safe return to the skies.

I hope that most of our home-based GA community will have received confirmation of our Home-Based Aircraft discount scheme. I am aware that John will have commented on the scheme and I trust that, together will holding landing fees to 2020/21 prices, this is a welcome benefit to the GA community.

Finally, I hope you all stay safe and well.
