### FLIGHT SAFETY & PILOT FATIGUE

Those idiots in EASA are at it again – not satisfied with trying to legislate aviation out of business, they now want to make sure that, if that doesn't work, then they will make sure they take aircraft out of the sky another way – If it aint broke – don't fix it!!!!

There is a petition Supported by AOPA on the UK Government's e-petition site to protest about EASA's attempt to change the Flight Time Limitations that have worked for years to help to keep British (and European) commercial air transport safe.. The petition reads:

"We believe the UK Government has a duty to promote flight safety and protect the British public from unsafe rules and practices in aviation. We believe that the EU's current proposals on pilots' Flight Time Limitations, which are supposed to guard against pilot fatigue, are commercially-driven and scientifically-unsound. Under the EU proposals, tiredness could impair pilots' abilities to the same extent as flying with several times the legal blood alcohol limit. We note that the US FAA, will be publishing its own fatigue rules soon which will strengthen flight safety regulations, not relax them as the EU proposals do. We call on the UK Government to stand up for flight safety and publicly announce it will oppose EASA's current proposals (NPA 2010-14), use its influence to persuade other Member States of that position and work to bring EU flight safety regulations up to the 'gold standard' of aviation safety we have here in the UK."

If you have yet to sign the petition (which has just under 12,000 signatures as at the time of writing), please go to the site and register your support and stop these unelected Bureaucrats from jeopardising air safety – it can be found at: <u>www.flightsafetypetition.co.uk</u>

Everyone involved in aviation will understand the importance of Flight Time Limitations on air safety and will want to support this – but in fact, anyone who ever travels by air should actually be worried about this attempt to jeopardise their safety...

Over the last month, aviation and airports have stayed in the forefront in the media. Not always for the best reasons of course, but it is good that the public are so aware of the importance and (in some ways) fragility of our main gateways. The debate around the options of a new hub airport; linking of existing airports; or additional runway provision in some shape or form is generally interesting and we are both monitoring and taking part in the debates. As well as being a leisure and business airport to the current users, Biggin Hill is one of only three commercial airports inside the M25, and it is important that we are aware of the discussions.

The Border Agency has been on the media radar over this last month - both in relation to the apparent relaxation of checks at the ports of entry, and more recently in relation to the public sector industrial action today. It has been good news for Biggin Hill that our border remains as secure as ever, and UKBA confirmed last week that we would have full coverage today. The anticipated impact of such action is as damaging as any actual impact, and thankfully we came through unscathed on both fronts. We appreciated the volunteer coverage from UKBA today.

Thank you to everyone who attended the GASCO Safety Road Show on 14th November. I hope it was useful and the feedback received through our SATCO was very positive. Any suggestions or comments will be well received. I understand that the Olympics prompted a significant amount of discussion, and we are looking at ways to keep you, our customers, well informed, well in advance.

We continue to look at options for the Hotel site, as we would like to see this in place as soon as possible - something which I hear often from residents and users of Biggin Hill.

Our relationship with the local communities is a high priority for me, and if there is a group of residents or interested parties, I am always glad to attend a meeting to discuss the Airport. We were glad to be the title sponsors of the Bromley Business Awards, and to select and present the award to the winners - Green Oil UK Ltd (www.green-oil.net).

Lastly, I was thrilled to be invited to switch on Biggin Hill's Christmas Lights this year. I realise that I am a far cheaper alternative to the big stars of stage and screen (!), but it was a really enjoyable experience and I was relieved not to blow any fuses at the vital moment.
