## **MONTHLY REPORT FROM THE OFFICE OF WILL CURTIS**

The last month has been busy for the management team at Biggin Hill. We have had variable traffic levels with some very busy days and some much quieter periods. The ongoing road works on Leaves Green Road are damaging our business to a large degree as aircraft operators avoid using the airport due to the excessive delays caused by this never ending repair work.

Whilst this replacement of the gas mains by SGN will hopefully cure any gas leaks, Thames Water declined to take the opportunity to replace the adjacent and very aged water main which is apparently on their program "within the next 5 years". In the meantime the monthly expedition on the part of Thames Water to frustrate locals going about their legitimate business by digging up Leaves Green road will continue and then at some point the road will apparently be closed entirely for a considerable period to facilitate a new water main. I suggest that you make sure that your larder is full (because Biggin Hill will be cut off from the outside world) and please feel free to write to your MP and ward Councillor to express your frustration at this inexcusable lack of joined up thinking and regulatory control over the profiteering antics of the utility companies. If we make enough noise someone may eventually listen to us ordinary folk, although as you will see below, listening appears not to be Council's strongest point.

As mentioned last month, we have applied to the Council for the extended airport operating hours upon which we consulted with local residents so extensively. The Council, quite incredibly, have now stated that they must carry out their own public consultation (something they previously said they did not have to do) and so we are more than a little frustrated with their approach.

A number of global companies have expressed interest in locating their UK operations at Biggin Hill, but they will not commit to us until we have the requisite approvals in place. Meanwhile the usual band of anti-airport fanatics are spreading false rumours around and about the community. You will all remember that scaremongering that took place last time the airport looked to change the status quo - well it seems that their latest stunt is to claim that Paris Charles De Gaulle Airport is due for imminent closure and that it is planned that all Charles De Gaulle traffic will be relocated to Biggin Hill Airport (which I am sure you will agree will be very convenient for downtown Paris!). Someone has evidently been at the Christmas sherry too early...

Seriously though, we need to ensure that we all take part in the Council's own consultation and respond positively as, if we are not careful, the small minority of "antis" will yet again get a disproportionate amount of air time and attention. It seems that the NIMBYs are not interested in jobs for the younger generation, nor in the future success of the airport which they would ideally like to see closed for good. They slate the airport openly for failing (in their opinion) to support the heritage of the airport, all the time ignoring the fact that the airport has volunteered, for no reward, to underwrite the cost of operating a heritage centre if it can be built and to underwrite the cost of maintaining and protecting St. Georges chapel if and when the MOD decide to take it off their books. It is difficult to see what more we might do to support the heritage of the airport. We see our heritage as important and we are keen to protect and honour the history of Biggin Hill airport for future generations, but this will cost money and money, as you all know, does not grow on trees. It has to be earned by commercial activity. The antis, it seems, care only about themselves. The fact that many of them moved into their very substantial houses around the airport, or under its approach, relatively recently and certainly long after the airport was in operation does not seem to matter to them at all. Ironically, they seem as keen as us on honouring the heritage of the airport. They believe, it seems, that Biggin Hill airport can survive purely to service the odd Spitfire flight and host some bits of bent metal carefully placed in an exhibition centre.

Of course, it is more complicated than that, and the £6 million annual cost of operating an airport of this size can only be met by commercial Business Aviation traffic. In the absence of that, I can see Biggin Hill falling prey to airlines, or alternatively following in the footsteps of West Malling aerodrome - also an important WWII fighter base - whose heritage is now buried under 1,500 affordable homes.

Ironically the intransigence of the antis today will likely spell disaster for tomorrow, because if we do not move forward in Business and General Aviation, I fear that we will become a target for regional airline traffic when London runway capacity starts to become really stretched towards the end of this decade. The antis claim that this is just scaremongering - perhaps they should actually read the various reports and government papers that pertain to this subject because if they did so,

they might find themselves unpleasantly surprised.

During the last week of November, Biggin Hill Airport Limited and Oxford Airport jointly took part in a judicial review hearing in the High Court. During this, the matter of the UK CAA's responsibility to regulate the safety aspects of civil air traffic even whilst using RAF airfields, and the MOD's responsibility to abide by EC Directive 216/2008 and to set standards at least as effective as those at equivalent civil aerodromes were considered.

RAF Northolt was the main consideration since they are currently able to attract a substantial volume of business aviation traffic without meeting safety standards that a civil aerodrome is forced to meet, and of course without any commercial risk because their wage bill is underwritten by the long suffering tax payer. They are not troubled by Uniform Business Rates, nor by CAA inspectors demanding six figure safety improvements, nor by the costs of aerodrome upkeep (which again are paid for by you and me), and yet they are very conveniently located 20 minutes from the West End, so they really do have a very unfair commercial advantage!

During the hearing, the MOD actually stated in their evidence that they could not consider reducing their runway length to comply with the requirement for an ICAO minimum of 90 metres of Runway End Safety Area because, if they did so, their runway would be too short to accept the larger business aviation types, and this would cost them lost revenues! It beggars belief that financial loss should be used as a reason not to comply with accepted minimum safety standards. I must try that argument on the UK CAA aerodrome inspectorate next time they demand some expensive upgrade!

You will all have seen press coverage, at the end of November, concerning a Gulfstream III that managed to leave the paved surface of the runway whilst manoeuvring for take-off. There is little doubt that this was simple pilot error, but the matter was handled in exemplary manner by the airport fire service and no one was hurt so, whilst the aircraft is somewhat rearranged and probably too old to be worthy of repair, we can be thankful that all ended well. Apologies if you were delayed whilst the operation to clear the runway was in progress the following day.

Christmas has now long passed, and New Year is upon us again, and it only remains for me to wish you all a very happy and prosperous 2015.
