BIGGIN WEATHER?

April was rather a mixed month from a weather point of view, with virtually a week of poor weather and dense fog early in the month, followed by a period of around a couple of weeks of excellent flying weather, which included several days of record breaking temperatures (I'm told the hottest April temperatures for some 70 years!). Certainly it made a wonderful change to actually be able to fly light aircraft for several consecutive days for probably the first time this year. Let's hope this is the start of a wonderful Summer's flying...

FESTIVAL OF FLIGHT 18th & 19th AUGUST 2018

Once again the Festival of Flight will be a two day extravaganza, celebrating 100 years of the Royal Air Force, at Biggin Hill on 18th and 19th August 2018. Once again timed to co-incide with the Eastbourne Air Show, it promises to be an event not to be missed.

Tickets for the event, which will not be available on the day, are now available online - see: <https://lbhacommunity.ticketsrv.co.uk/> and are available at an "early bird" discounted rate of £23.50 per adult (Up to two children under 16 admitted free with every Adult ticket holder) - normal ticket price will be £29.00 (children aged 3 or less are free).

(For bona fide Biggin Hill residents, who are not seeking space in a Hospitality Enclosure, special residents "walk in" tickets will be available at the same price as last year, from 7th May. They will be available from the Lookout Café on the airport, and the Spitfire Café in Biggin Hill village. Remember though they are "walk-in" only – cars will not be permitted with these special tickets!)

BRONZE HOSPITALITY ENCLOSURE

Instead of running our own Enclosure and Marquee this year, Users and Tenants and their guests will have access to the "Bronze" Hospitality Marquee and Enclosure on the flight line on the Sunday 19th and we have negotiated a discounted ticket price (which includes Show Entry and 2 course BBQ lunch).

The "Bronze" Hospitality Enclosure, is of a similar style to our previous marquee but without the need to buy separate show entry tickets as well as marquee tickets, as they have been combined. It is normally priced at £50 per person (£20 age 12 and under) including show entry and free BBQ. However we have an exclusive allocation, for a limited period, of discounted tickets at £45 per person (£18 age 12 and under) - children aged 3 and under are free.

The show organisers held back 100 of the 200 tickets for airport users and tenants and these will be held for us exclusively only until 18th May, thereafter any unsold tickets will be released for public sale!

Included in the Bronze Marquee Hospitality price is:

Entry to the Air Show itself
Private VIP entrance and car park
Free Event Programme
Use of the Marquee with its own garden area
Executive toilets
Free BBQ and salad buffet, followed by strawberries and cream
Pay bar
Child friendly space with entertainers provided for part of the day

Children's ticket price is valid for ages 4 to 12 inclusive, with those age 3 and under free.

(Special Note: Unlike in previous years, Hospitality guests will NOT be permitted to bring in their own food or alcoholic drinks, except for crisps/nuts/soft drinks for children who are under drinking age. There will be a pay bar within the enclosure.)

Please note the discount code to enter is: TENANTS

Following entry of the discount code, you will be presented with a Hospitality purchase page giving you the ability to select the required number of "Hospitality Bronze Family Marquee" tickets for Adults and Children.

Below that is the number of *ADDITIONAL* normal showground entry tickets - you do NOT need show entry tickets as well for Hospitality guests as that is included in the overall "Hospitality" ticket price!

Please remember, don't delay - these are likely to sell out quite quickly and once our allocation has been fully subscribed or the 18th May deadline is exceeded, further Hospitality tickets are unlikely to be available at any price.

STOP PRESS

At the time of publication, just based on word of mouth we have already sold 60 places, so there are now just 40 tickets out of the 100 allocation left, and the publicly available tickets have already sold out – if you want to be in the Enclosure – buy them today or it may be too late!

MONTHLY REPORT FROM THE OFFICE OF WILL CURTIS

March was a month blighted by poor weather and although the airport made budgeted levels of business aviation, light aviation was considerably down as a result. Then beyond past that, in early April an extensive period of dense fog contributed to the misery, before we went from deepest Winter to searing mid-summer in 48 hours flat. Let's hope that Spring has arrived at last!

Many of you have written to me asking why we are reducing light aviation movements from 33,000 to 12,000 annually and I therefore repeat that which I have previously set out. We are addressing a matter of safety and nothing else. We have no anti light aviation agenda nor any desire to see light aviation precluded from the airport - we just need to maintain a safe and manageable air traffic environment and with the recent growth in business jet movements and the advent of TCAS on board all business jets, we can no longer safely support high volumes of light aviation at the

airport. Many of you refute this as being fiction, but with great respect we are the beneficiaries of the output of a well-developed airport wide Safety Management System and that system clearly identifies the issues surrounding the current mix of disparate air traffic. We therefore have no option but to act upon its output and to mitigate any risk by reducing light aviation to a more manageable level as expeditiously as possible.

Sadly, last month's Safety and Noise Abatement Review Board (SANARB) was forced to take the unusual decision to exclude two light aircraft pilots from using the airport. One had deliberately defied ATC instructions whilst the other had continued flight into weather conditions for which he was not licensed and then lost control of the aircraft concerned whilst in IMC, coming very close to crashing into terrain with attendant fatalities. In the latter case a file of evidence has been sent to the CAA enforcement branch for consideration of further action. The SANARB took the view that if the Airport were minded to reduce the volume of light aviation then it was appropriate to exclude those who threaten safe airport operations thereby leaving more space for those who operate sensibly and within their own limits. I admit that I find this logic compelling. If pilots choose to put themselves and even others at risk by an avoidable lack of airmanship and it subsequently comes to our attention (and it does because it is all recorded by the NMTKS and ATC tapes), the SANARB will probably ask those to operate elsewhere (always assuming there is anyone left alive to talk to) and the CAA may well go on to take an unwelcome interest in the matter.

The new hangar is now complete and has been handed over. The offices require some furniture and partitions but are ready for occupation by tenants and we expect the first tenants to move in within a month or so.

Meanwhile the resurfacing work for taxiway Hotel is out for tender, as is the work required to build a link taxiway between the southern end of the main apron and the runway. The runway 03 GPS approach continues its journey through the regulatory maze and we hope it will emerge intact shortly, after which we will begin implementation.

Now that the fine weather has arrived might I ask everyone to refresh their memory regarding noise abatement procedures and ensure that flights are operated in such a manner that they remain clear of noise sensitive areas. In particular, please do not leave propellers at fine pitch longer than is necessary and reduce power where it is safe and sensible to do so in order to keep noise levels down as far as may be practically possible. Please also avoid overflying the houses to the right of runway 21 along the A233. Whilst we require a 10 degree right turn (track change) after departure for noise abatement in the village of Biggin Hill, this should not be commenced until the upwind end of the runway has been reached. Residents of these house are fed up with overflights by low flying departures that have made an early right turn, so please avoid this error. Thank you in advance for your cooperation.

We were pleased to welcome Andrea Leadsom, Leader of the House of Commons, to Biggin Hill Airport last week. Andrea toured the Bombardier facility and was impressed with the industry here at the airport and expressed support for the initiatives we are pursuing as an airport community. She was accompanied by various members of the Council and by the Tory candidates for Biggin Hill in the upcoming local elections. All were pleased to learn that over 80% of our airport wide revenues are made up of exported services (ie. services supplied to overseas registered aircraft visiting the UK for business or maintenance) and to learn that we are good for the local economy and for UK PLC too!
